



## **KINGDOM DREAMS HOMEOWNERS' ASSOCIATION, INC. ARCHITECTURAL CONTROL GUIDELINES**

In order to maintain the high standard of living in KINGDOM DREAMS HOMEOWNERS ASSOCIATION, INC., the Architectural Control Board must give written approval for all alterations, additions, improvements and landscaping.

1. No building, exterior, wall, fence or other exterior structure shall be commenced, erected or maintained without written approval from the Board of Directors.
2. You can only paint the exterior of your home in a color authorized by the Association and you must have written approval from the Board of Directors prior to beginning painting.
3. All modification of the landscaping must be submitted with plans that include specifications showing the nature, kind, shape, height, materials and location of landscaping improvements.
4. Any and all changes to your front walkway or driveway or addition to your back patio must be submitted in writing for approval.
5. The application must be submitted with the following information:
  - A detailed plan or drawing with dimensions. An architectural rendering is not necessary, but it is preferable.
  - Samples of color, tile, brick or other materials being used.

Please attach the following to this request: 1. a copy of the contractor's license. 2. The Certificate of Liability. The Certificate Holder must include the name of the property owner and the property address.

**You are responsible for obtaining any required building permits from Miami-Dade County.**

NOTE: Please allow time to process your request. It can take as long as 30 to 45 days before you receive a reply to your request.

For further information, consult your Association Documents.

The attached **ARCHITECTURAL MODIFICATION REQUEST FORM** must be used. **NO OTHER FORM WILL BE ACCEPTED** by the Architectural Control Board. Please submit a completed form and any attachments to the management company.
